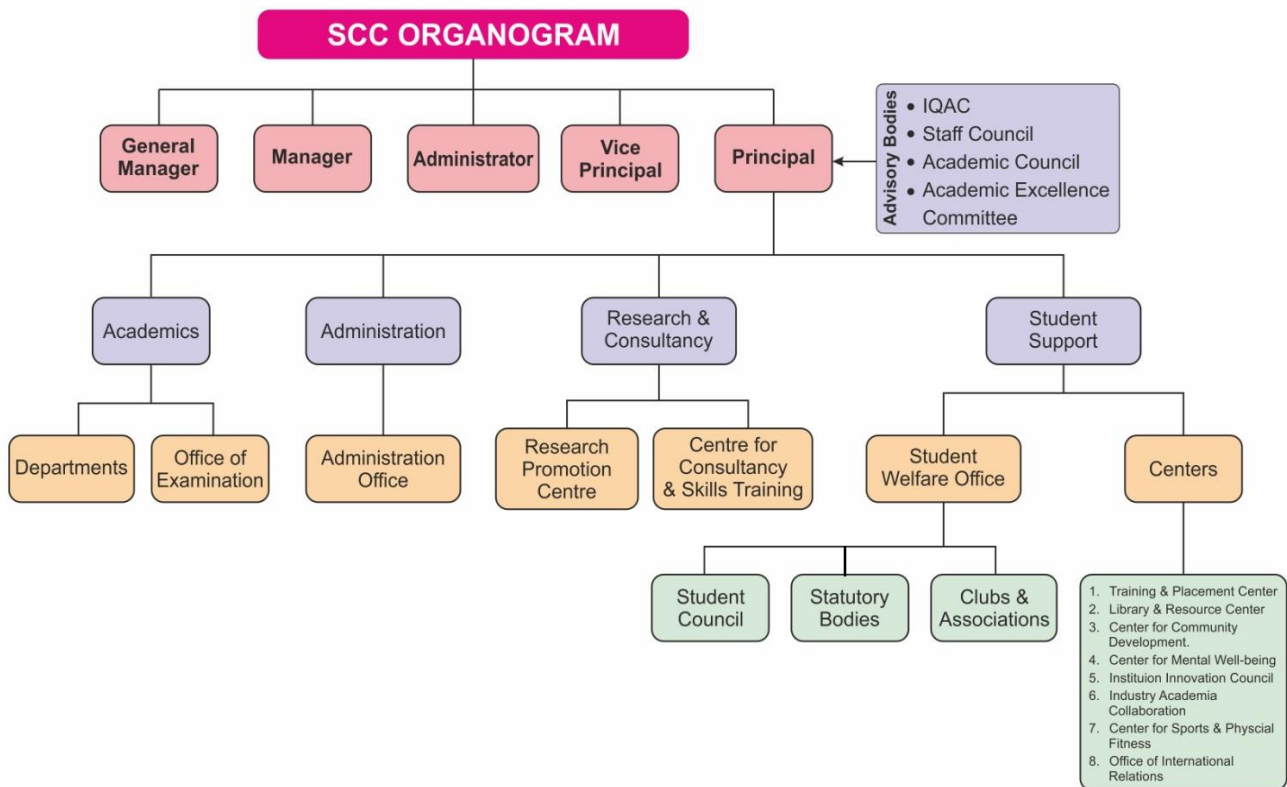

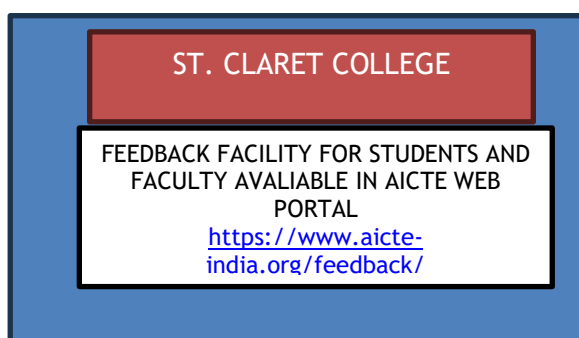
- **Establishment of Anti Ragging Committee**
